

<u>2024 – 2025 Congressional Youth Advisory Council</u>

The Congressional Youth Advisory Council (CYAC) is a leadership opportunity for high school students in the 24th Congressional District of Texas to participate in an interactive learning experience and develop leadership skills.

Participation in the Congressional Youth Advisory Council offers students a unique opportunity to learn about the federal government, discuss public policy, and work with their federal representative while serving their community.

Through the program, students will strengthen critical thinking and problem-solving skills by assessing the role of the federal government as it relates to issues within the 24th Congressional District of Texas while enhancing their public speaking and writing skills.

<u>Eligibility Requirements</u>

- Open to public, private, and home-schooled high school students.
- Student must be enrolled in 9th, 10th, 11th, or 12th grade.
- Student must be able to attend each of the six separate program meetings, three each academic semester.
 - Fall meetings will take place on the following Saturdays, September 28, October 19, and November 16.*
 - \circ Three (3) Spring meeting dates will be announced in December 2024.

*Note: All meeting dates are subject to possible changes in the Congressional calendar.

Personal Statements (2): Submit two 200-word essays on the following topics:

- 1) What is an experience you have had, position you have held, or goal you have accomplished that has prepared you to serve on the CYAC?
- 2) Why are you passionate about serving your community and country?

Resume: Detail all high school involvement and extracurricular activities; including leadership positions, athletic activities, volunteer experiences, etc. **Please limit your resume to no more than two (2) pages.** *Any additional pages will not be considered during the review process.*

Letters of Recommendation (2): Letter should focus on applicants' character, leadership qualities, and interest in public service.

- Provide <u>one</u> of the letters from your high school principal, assistant principal, advisor, or teacher who can best speak to your character, leadership, etc. That is the only letter of recommendation I want from your school.
- Provide <u>one</u> of the letters from an employer, a mentor, a family friend, etc.
- These letters should **<u>not</u>** be written by immediate family members.
- Please ask the recommender to physically sign their letter, no digital signature.
- Letters of recommendation can be submitted in the following ways.
 - Directly from the recommender.
 - 1. Mailed to the Dallas District Office The letter needs to be in a sealed envelope with their signature across the seal of the envelope to ensure it has not been opened/altered.
 - 2. Uploaded through a secure link. Please provide their email address and our office will send them the link to upload their signed letter.
 - Included in your application packet. The letter needs to be in a sealed envelope with the author's signature across the seal of the envelope to ensure it has not been opened/altered.
